

INSURANCE BY MORE THAN ONE COMPANY

When we and other companies write insurance covering the insured premises, our limit of liability for the Property Coverages is __ % of the total limit of liability for all insurance covering the same property. We pay this percentage of any loss under Property Coverages caused by perils insured against but not more than the limit of liability stated in the Declarations or any endorsement.

Any special limit or amount of insurance shown in this policy shall be the limit of liability for all insurance, and we shall pay no more than the above percentage of the special limit or amount of insurance. *Insurance By More Than One Company* is insurance written in your name by more than one company using the same type of policy and conditions, whether or not still in force at time of loss.
