

POLICY ENDORSEMENT

We provide coverage under this endorsement subject to the *terms* contained in *your* policy.

ADDITIONAL EXCLUSIONS

The exclusions applicable to the Personal Liability and Medical Payments coverage of *your* policy are supplemented with the following additional exclusions:

- 1. This personal liability coverage does not apply to liability for *bodily injury* or *property damage* caused intentionally or maliciously by or at the direction of any *insured*. This exclusion applies even if the *bodily injury* or *property damage* was not intended or was different than what was intended. *Bodily injury* and *property damage* resulting from the use of reasonable force to protect people or property are excepted from this exclusion;
- 2. This personal liability coverage does not apply to liability arising directly or indirectly out of instances, occurrences or allegations of criminal activity by any *insured* or *employees* of an *insured* named in this policy.

All other terms and conditions remain unchanged.
