DEFINITIONS

The following definitions apply to this policy form:

- 1. **Automatic cooking protection system** means any automated cooking protection system that includes sprinklers, discharge nozzles and ducts, pipes, valves, fittings, tanks and their component parts, pumps and fire protective mains that are all connected to and integrated with the system for the purpose of protecting only cooking equipment and cooking exhaust systems.
- 2. Security guard means a person employed to guard your property at your direction on the insured premises.

ADDITIONAL CONDITION

As a condition of this policy, *you* will exercise due diligence to maintain in complete working order all equipment and services pertaining to the operation of the protective safeguards Clause shown in the Schedule.

If you fail to comply with the conditions contained in this endorsement for the protective safeguards Clause shown in the Schedule which are under your control, we will not pay for any claims resulting from fire. You must give immediate notice to us of any impairment in or suspension of the protective safeguard within your knowledge.

PROTECTIVE SAFEGUARDS

1. Automatic Sprinkler System

Clause A

Any fire suppression or extinguishing system not connected to a central sprinkler supervisory service.

Clause B

Any fire suppression or extinguishing system connected to a central sprinkler supervisory service which are under the control of the *insured*.

You have **our** permission in the case of breakdown, leakage, freezing conditions or the opening of sprinkler heads, to shut off the part of the sprinkler system necessary to make repairs. Repairs will be made as soon as reasonably possible. Notify **us** immediately at the time of the disruption of the operation of the system. **You** must also notify **us** prior to any alteration of the sprinkler system.

2. Automatic Fire Alarm

Clause C

An automatic fire alarm protecting the entire building, connected to a central station or reporting directly to a public police or fire department station.

Clause D

An automatic fire alarm protecting the entire building, with an outside connection.

3. Security Guard With A Recording System Or Watch Clock

Clause E

Security guard service with a recording system or watch clock making hourly rounds at such times the *insured premises* are not in actual operation.

Clause F

Security guard service with a recording system or watch clock making hourly rounds at such times the *insured premises* are not in actual operation with all rounds of the *security guard* being recorded through a central station.

4. Automatic Cooking Protection System

Clause G

An automatic cooking protection system.

You have **our** permission in the case of breakdown, leakage, freezing conditions or the opening of sprinkler heads, to shut off the part of the **automatic cooking protection system** necessary to make repairs. Repairs will be made as soon as reasonably possible. Notify **us** immediately at the time of the disruption of the operation of the system. **You** must also notify **us** prior to any alteration of the **automatic cooking protection system**.

5. Other Protective Safeguard(s)

Clause H

Equipment and services pertaining to the operation of the protective safeguard described in the Schedule.

All other terms and conditions remain unchanged.
