The following Clauses and Conditions are added to this policy. Failure to comply with the Protective Safeguard Clauses specified as applicable in the schedule above shall suspend this insurance in accordance with the provisions contained in this endorsement.

- A. Automatic Sprinkler Clause (Non-Supervisory).
- B. Automatic Sprinkler Clause (Supervisory).

In consideration of the premium at which this policy is written, it is a condition of this policy relating to Clauses A and B that the *insured* shall:

- (1) exercise due diligence in maintaining in complete working order all equipment and services pertaining to the operation of a sprinkler system (Clause A) or pertaining to the operation of a sprinkler system in connection with an approved central sprinkler supervisory service (Clause B) which are under the control of the *insured*;
- (2) give immediate notice to *us* of any impairment in or suspension of the sprinkler system or services within the knowledge of the *insured*;
- (3) add no sprinkler additions or extensions to the *insured premises* unless immediate notification is given to *us*;
- (4) have *our* permission in the case of a break, leakage, freezing conditions or the opening of sprinkler heads to shut off the water from so much of the sprinkler system as may be necessary to make repairs—such repairs to be made as quickly as possible—while at the same time notifying *us* immediately at the time of; the disruption of the operation of the system.

- C. Automatic Fire Alarm Clause No. 1.
- D. Automatic Fire Alarm Clause No. 2.

In consideration of the premium at which this policy is written, it is a condition of this policy relating to Clause C and Clause D that the *insured* shall:

- (1) equip the entire building with an approved automatic fire alarm connected to an approved central station or reporting directly to a public police or fire department station (Clause C) or equip the entire building with an approved automatic fire alarm system with outside connection (Clause D); and
- (2) exercise due diligence in maintaining in complete working order all equipment and services pertaining to the operation of this system which is under the control of the *insured*; and
- (3) give immediate notice to *us* of any impairment in or suspension of the automatic fire alarm equipment or service within the knowledge of the *insured*.

- E. Watchman and Clock Clause No. 1.
- F. Watchman and Clock Clause No. 2.

In consideration of the premium at which this policy is written, it is a condition of this policy relating to Clause E and Clause F, that the *insured* shall:

- (1) exercise due diligence in maintaining in complete working order all equipment of the approved watchman's service with approved recording system and watch clock at such times as the premises are not in actual operation (Clause E) and maintain in complete working order all equipment and services pertaining to the operation of the approved watchman's service with approved recording stations at such times as the premises are not in actual operation with all rounds of the watchman being recorded through an approved central station (Clause F). In both clauses, the watchman's service must be under the control of the *insured*.
- (2) give immediate notice to *us* of any impairment in or suspension of the watchman's service within the knowledge of the *insured*.

G. Other Protective Safeguard Clause(s).

In consideration of the rate at which this policy is written, it is a condition of this policy relating to Clause G that the *insured* shall:

- (1) exercise due diligence in maintaining in complete working order all equipment and services pertaining to the system;
and
- (2) give immediate notice to *us* of any impairment in or suspension of such equipment or service within the knowledge of the *insured*.
